OTHER:

Career Tech Ag Teacher:	Minimum Salary + \$2,600/year (12 mo. contract)
Career Tech Ag Teacher (Summer):	Minimum Salary / 12 X 2 months (12 mo. contract)
Other Career Tech Teachers:	Minimum Salary + \$2,200/year
Special Education Teachers:	Minimum Salary + 5% above Base Salary
Alternative Education Teachers:	Minimum Salary + 5% above Base Salary

If a teacher chooses to participate in a major medical health insurance plan they will receive \$640.28 per month for their FBA.
 If a teacher chooses to take the amount as taxable compensation instead of insurance, they will receive \$69.71 per month, per legislation.
 The amount of TRS offset that is paid per Senate Bill 776 will be included in total salary.
