# RESOLUTION

A RESOLUTION AUTHORIZING THE CALLING AND HOLDING OF AN ELECTION OF INDEPENDENT SCHOOL DISTRICT NUMBER 7 OF TULSA COUNTY, OKLAHOMA FOR THE PURPOSE OF SUBMITTING TO THE REGISTERED QUALIFIED ELECTORS THEREOF THE QUESTION OF THE ISSUANCE OF THE BONDS OF SAID SCHOOL DISTRICT IN THE SUM OF THIRTEEN MILLION FOUR HUNDRED SEVENTY THOUSAND DOLLARS (\$13,470,000) TO PROVIDE FUNDS TO BE ISSUED IN SERIES FOR THE PURPOSE OF CONSTRUCTING, EQUIPPING, REPAIRING AND REMODELING SCHOOL BUILDINGS, ACQUIRING SCHOOL FURNITURE, FIXTURES AND EQUIPMENT, AND ACQUIRING AND IMPROVING SCHOOL SITES AND LEVYING AND COLLECTING AN ANNUAL TAX IN SUCH DISTRICT FOR THE PAYMENT OF THE INTEREST AND PRINCIPAL OF SAID BONDS.

WHEREAS, it is deemed advisable by the Board of Education of Independent School District Number 7 of Tulsa County, Oklahoma, to construct, equip, repair and remodel school buildings, acquire school furniture, fixtures and equipment and acquire and improve school sites; and

WHEREAS, there are no funds in the treasury for such purpose and power is granted said Board by Article X, Section 26 of the Oklahoma Constitution and Title 70, Article XV of the Oklahoma Statutes 2011, and laws supplementary and amendatory thereto, to issue bonds to provide funds for such purpose provided the same be authorized by the registered qualified electors thereof, voting at an election held for that purpose.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION OF INDEPENDENT SCHOOL DISTRICT NUMBER 7 OF TULSA COUNTY, OKLAHOMA:

# SECTION 1:

That a special election is hereby called in said School District to be held on the 14<sup>th</sup> day of February, 2023, for the purpose of submitting to the registered qualified electors of such School District the following proposition:

# **PROPOSITION NO. 1**

"Shall Independent School District Number 7 of Tulsa County, Oklahoma, incur an indebtedness by issuing its bonds in the sum of Thirteen Million Four Hundred Seventy Thousand Dollars (\$13,470,000) to provide funds to be issued in series for the purpose of constructing, equipping, repairing and remodeling school buildings, acquiring school furniture, fixtures and equipment and acquiring and improving school sites and levy and collect an annual tax, in addition to all other taxes, upon all the taxable property in such District sufficient to pay the interest on such bonds as it falls due and also to constitute a sinking fund for the payment of the principal thereof when due, said bonds to bear interest not to exceed the rate of ten (10%) percentum per annum, payable semi-annually and to become due serially within ten (10) years from their date?"

### SECTION 2:

That such call for said election shall be by proclamation and notice signed by the President or Vice-President and attested by the Clerk or Deputy Clerk setting forth the proposition to be voted upon, the number and location of the polling places, the hours or opening and closing of the polls, the names of the officers who shall conduct said election and the substance of Section 4 hereof that the ballots shall set forth the proposition to vote upon substantially as set out in Section 1 hereof, and that the returns of said election shall be canvassed and certified to by the County Election Board.

### **SECTION 3:**

That the number and location of the polling places and precinct officers for said election shall be as prescribed by the County Election Board.

#### **SECTION 4:**

That the specific projects for which at least seventy (70%) percent of the proceeds of the aforesaid Bonds shall be expended and the dollar amounts for each project shall be as follows:

Construct, equip and furnish a new SE Gymnasium/ Storm Shelter to include but not be limited to: site preparation, foundation work/steel and concrete, exterior partitions, roof and roofing fixtures, HVAC, interior partitions, electrical equipment and fixtures, plumbing equipment and fixtures, doors, flooring and additional school district furniture, fixtures equipment \$5,760,000.00 Construct, equip and furnish Auditorium Stage Upgrades to include but not be limited to:

\$1,615,000.00

Construct and repair the Activity Center foundation issues; construct and repair parking lot maintenance;

lighting/rigging/sound board/wiring and curtain system and construct, equip and repair roofs

and guttering district wide

construct, repair and remodel the Facilities Upgrades to include but not be limited to: HVAC, painting, plumbing, electrical and fencing; acquire and install Security Hardware/ doors and other Security Enhancements, acquire technology upgrades district wide to include but not be limited to: smart panels, chromebooks and other technology upgrades and acquire and install new Stadium Turf and acquire maintenance equipment/vehicles
